## Fly America Experts

A quick guide to compliancy with the Fly America Act.

### The Fly America Act: A quick reference

"Federal travelers are required by 49 USC 40118, commonly referred to as the 'Fly America Act', to use US air carrier service for all air travel and cargo transportation services funded by the US government".

#### Q. Do I have to fly on a US airline?

#### A. No.

The US Government has entered into several bilateral air transport agreements with other governments, commonly referred to as 'Open Skies Agreements' which means travel can be provided by foreign air carriers headquartered in those regions. As of July 2017, these agreements exist with:

- The European Union
- Australia
- Switzerland
- Japan
- Iceland



**Q.** Can I use 'codeshare' flights with non-US airline's from countries that don't have a bilateral agreement with the US Government?

#### A. Yes.

In this day and age the airline industry is complicated, with many airlines sharing planes in order to provide their travelers with additional capacity, routes and to maximize their revenue opportunity. If travel is provided by a foreign carrier that doesn't have a bilateral agreement with the US Government, it is still Fly America compliant as long as the ticket is booked as using the US airline's flight number.



- **Q.** Can I book a ticket with the airline sharing the flight using their flight number if it's a lower price than the US airline's ticket?
- A. No, unless it's with an airline that has a bilateral agreement with the US Government.

#### Examples:

- 1. Washington DC to Addis Ababa operated by Lufthansa. Compliant under Open Skies.
- Washington DC to Addis Ababa operated by and ticketed as Ethiopian Airlines flight number.Not compliant.
- Washington DC to Addis Ababa operated by Ethiopian Airlines ticketed as United flight number.
  Compliant under code share (ticketed on US Airline).

Even if example 2 is lower in price than example 3, which is the same flight, option 3 must be used.

#### Other exceptions

There are a number of other exceptions to the Fly America Act, including but not limited to the total duration of the flight compared to the US Airline, as well as the number of stops. Other exceptions include medical cases and special arrangements in an emergency situation. **This level of detail is best left for your Travel Consultant to guide you case by case.**
